WATER REPORT

- Well #4 Report
 - ➤ Plumbing is 90% complete
 - ➤ HVAC 95% complete
 - ➤ Electrical 60-70% complete
 - > Generator to be delivered and installed in July
 - > Iron Filtration delivery and install is still set for late April to early May
 - > We met regarding SCADA implementation and needs for the well #4 and the remainder of the water system.
- The last remaining hydrant was removed from the Metalcraft loop site as we had requested in early planning stages.
- The consumer confidence report was submitted to the DNR and published.
- The rate case hearing through the PSC is on the docket and set for 5/1.

WASTEWATER REPORT

- We started whole effluent toxicity testing this week.
- Facilities planning is at the 30% design completion phase.
- Regarding cost for this project, misinformation has been circulating and I'd like to clarify-the project cost for facilities planning is not \$35 million. Initial estimates placed the project around \$25 million and I did confirm that with inflation these numbers remain the same. This number does not account for the principal forgiveness we are eligible for which lessons the total cost. Our project timing is directly in line with the unprecedented funding available. This project is funded by a DNR loan program offering grant funding deducted from principal on a 20 year term at a rate near 2%.
- We researched product and spoke with other municipalities before meeting with MSA regarding equipment selection for the facilities project.
- I submitted the required response regarding the notice of noncompliance received from the DNR. We are working with our industrial customer to ensure operations are in order prior to their season start. Our limit is very close to our average daily concentrations. Any upset including industrial operations, snow melt, etc. is very easy to upset this balance. These are mostly out of our control. This also applies to leachate acceptance. We would never make our permitted regulations. The fine for these occurrences noted at the end of the noncompliance letter was \$25,000 per day of noncompliance.
- This morning, we lost all power to the plant. Internal breakers are extremely weak and unable to be replaced. Since the generator was receiving eternal power, it never ran. SCADA systems were not able to alarm without power.
- Lost HVAC services
