3. Citizens Comments.

4. Discuss Ambulance Rates and Current Muni/Township Contracts. Christine- **Recommends 10% increase. Budgeting for ambulance is difficult. Julie is the only full-time employee, going to make a request for a second full time employee soon. Maintain rates for the year for patients. Will base rates off next study.**
5. Statistical Report. **In packet- share breakdown of calls for service. Discussion of what is in the works. Gross is over \$1 million charged. A lot in collection. Spike in amounts is dependent on time of year, Medicaid, taxes coming in for people. Saw higher percentage from age 50-89. Mayville largest user of services. 87 of calls was to Village of Lomira. Number one on county strike team. Still are transporting whatever hospitals/facilities patients would like to go within reason and depending on situation due to good staffing amount. Number of treatments provided. Less than 4 percent of calls need paramedic help. Hopefully receiving a large grant. Awarded grant from Marshfield Clinic. Also received a grant for power chairs for stairs. Only thing paid with contract money goes towards equipment repairs. Have to take a loan for \$80,000 for new vehicle. Julie and Devin started teaching school, making staffing better and helping a lot. Last class got 3 new EMT's out of it.**

6. Report of Ambulance Equipment Replacement Account.

Hopefully receiving a large grant. Awarded grant from Marshfield Clinic. Also received a grant for power chairs for stairs. Only thing paid with contract money goes towards equipment repairs. Have to take a loan for \$80,000 for new vehicle.

7. Discuss Medical Control.

Continues to be a high standard. Second to none. Give a lot of Opportunities. Aurora continues to be great.

8. Covid19 Report. **Some calls but nothing drastic. Mostly common colds seen. Not worried about it. Masks no longer needed.**

9. Discuss Fundraising. **Had a golf outing. Made \$9,700. Maxed out on teams this year.**

10. Equipment Update-Ambulance Purchase & First Responder Unit 2954. **Hopefully purchasing new ambulance before next year. Should be good to go by the end of the year. May keep old ambulance, but do not have enough room for that at this time. Do have some funding for a new building but no plans for the near future on that. Right now we have 3 ambulances that get rotated throughout the year to make sure they are all getting used.**

11. Discussion/Comments from Village/Townships. **Have not received any complaints. Some time questions but got that down now. Positive feedback from Hustisford. Refreshing to have a service that's doing so well. Feel Mayville is a good model for others to follow.**
