### Call to Order

### Approval of Minutes of the July 22, 2024 Public Safety Committee

The motion to approve the minutes of the July 22, 2024 Public Safety Committee was made by Ald. DeBaker and seconded by Ald. Liebenow.

### Citizen Comment

Rick Breitzkreutz of 1082 Crystal Lane, spoke pertaining to the City of Mayville's noise ordinance. Mr. Breitzkreutz spoke of wishing to see Mayville's ordinance align more closely with other municipalities. He has recommended to have end times closer to 9-10 PM. He inquired if downtown events are getting different guidelines to follow.

### Monthly Fire Department Report to Public Safety Committee

None present to present.

### Monthly Police Department Report to Public Safety Committee

Chief Toellner spoke to the Committee. He provided staffing updates, a breakdown of calls for service, and an overview of the overtime breakdown. He further provided an overview of the upcoming community events which the police department will be a part of.

Chief Toellner also provided an emergency management update. He explained the tornado sirens are all currently working and provided explanation of upcoming changes and costs to the siren replacement project.

#### Monthly EMS Department Report to Public Safety Committee

Director Churchill spoke to the Committee. She provided an update on calls for service, staffing numbers, and upcoming work on licensure and policies and procedures for their schooling program and inter-facility transport. Julie Staffin, with EMS, provided an update on the upcoming EMT class.

#### Discuss, with Possible Action, Ambulance Contract Renewals for 2025, 2026, and 2027

Director Churchill spoke to the Committee. Recommend to continue the trend that previously set a 10% increase each year. She believes this rate of increase is a fair middle ground.

The motion to recommend Common Council approve the annual 10% rate increase for the ambulance contracts in 2025, 2026, and 2027 was made by Ald. DeBaker and seconded by Ald. Liebenow.

Vote – 3 ayes, 0 nays. Motion carried.

#### Discuss, with Possible Action, City of Mayville §317-5 Loud and Unnecessary Noise

Mayor Boelk provided the Committee an overview of this agenda item, pointing out where the City of Mayville ordinances may be confusing or contradictory. Chief Toellner provided an overview of the various ordinances and how the Police Department enforces them, pointing out the differences between ones that pertain to residential vs. non-residential areas, as well as striking a balance that fits the needs of the community.

Discussion was had amongst the elected officials and Rick Breitreutz, citizen commenter, including amplified music use, noise in residential vs. non-residential areas, differences for City events, overview of areas and venues in the City that may be more appropriate for amplified music, and the use of a block party permit.

The motion to table this agenda item to the September 23, 2024 Public Safety meeting was made by Ald. DeBaker and seconded by Ald. Liebenow.

Vote – 3 ayes, 0 nays. Motion carried.

**JOINT POWERS AGREEMENT  
COUNTY 911 EMERGENCY SYSTEM**

WHEREAS, Dodge County and the municipalities located within the boundaries of Dodge County have implemented an Emergency 911 System for the purposes of providing emergency services to residents and visitors of these municipalities, including fire fighting, law enforcement, ambulance, medical and other emergency services; and

WHEREAS, Sec. 256.35(9), Wis. Stats., "Joint Powers Agreement," requires that in implementing a 911 system as has been done in Dodge County, municipalities shall annually enter into a Joint Powers Agreement, which Agreement shall be applicable on a daily basis and which shall provide that if an emergency services vehicle is dispatched in response to a request through the Dodge County 911 System, such vehicle shall render its services to the persons needing the services, regardless of whether the vehicle is operating outside the vehicle's normal jurisdictional boundaries.

THEREFORE, in consideration of the mutual promises, agreements, and conditions contained herein, it is hereby jointly agreed between Dodge County and the City of Mayville, "municipality," as follows:

1. That effective January 1, 2025, this Agreement shall, thereafter, be applicable on a daily basis from said date through December 31, 2025.
2. That if an emergency services vehicle operated by the municipality, or operated by an agency with which the municipality contracts for that particular emergency service, is dispatched in response to a request through the Dodge County Emergency 911 System, such vehicle (whether owned and operated by the municipality or by the agency) shall render its services to the persons needing the services, regardless of whether the vehicle is operating outside the vehicle's normal jurisdictional (or as defined by contract) boundaries.
3. That a copy of this Agreement shall be filed with the State Department of Justice, as required by Sec. 256.35(9)(c), Wis. Stats.

## Chapter 317. Peace and Good Order

### § 317-5. Loud and unnecessary noise.

- A. General. No person shall make or cause to be made any loud, disturbing or unnecessary sounds or noises such as may tend to annoy or disturb a person of ordinary sensibilities in or about any public street, alley or park or any private residence.
- B. Sound-amplifying equipment. The following regulations shall apply to the use of sound-amplifying equipment within the City:
  - (1) Sound-amplifying equipment shall be permitted only to publicize events of community-wide interest and importance which are of a noncommercial nature.
  - (2) The only sounds permitted shall be music and human speech.
  - (3) Sound-amplifying equipment shall be used only between 9:00 a.m. and 5:00 p.m.
  - (4) No sound advertising shall be permitted on Sundays or legal holidays.
  - (5) The volume of sound shall be controlled so that it will not be audible for a distance in excess of 200 feet from its source and so that the volume of sound emitted therefrom shall not be unreasonably loud, raucous, jarring, disturbing or a nuisance to persons within the area of audibility.
- C. Construction and machinery noise. No person shall do construction work or operate any chain saw, lawn mower or any other loud machinery of similar nature between the hours of 9:00 p.m. and 7:00 a.m. except for emergencies. This provision shall not apply to public works construction or any other government projects.
