#### 5.a. Tax Incremental District No. 4

John Cameron with Ehlers was present. He provided an overview to the Board pertaining to tax incremental district no. 4, including lifespan, values, and fund balance. Discussion was had with Mr. Cameron and the Board pertaining to an extension on the life of this tax incremental district. Mr. Cameron indicated it may be a possibility.

#### 5.b. Tax Incremental District No. 5

Mr. Cameron provided an overview to the Board pertaining to tax incremental district no. 5, including lifespan, values, and fund balance. Mayor Boelk informed the Board that there is action being taken to pursue the money owed for the old Shopko property failing to meet annual base tax increment requirements, and that could assist this tax incremental district.

Mr. Cameron provided an overview to the Board pertaining to tax incremental district no. 6, including lifespan, values, and fund balance. A question was asked pertaining to the 12% test and where Mayville currently is with it, Mr. Cameron provided explanation.
