 - 1. Monday Night Women's Volleyball continues and will wrap up in early April
 - 2. Wednesday Night Womens Volleyball ended up with 6 teams and began play in February and will wrap up in April
 - 3. Bean Bag Leagues continues with 24 teams playing in 2 divisions .Play will wrap up in March
 - 4. Ping Pong League continues with 10 players wrapping up league play in late March
 - 5. Jr. Bucks Little Dribbler Basketball Program ran in January and February with 32 kids registered.
 - 6. Yoga is being held on Wednesday Nights with 12 people registered.

7. Mike is looking at increasing recreational offerings in the upcoming months. We will be actively looking for qualified Instructors.

Item #6 Update on ongoing Park Projects

1. East Street Parkland. Mike received notice of a \$5000 donation from Beaver dam Community Hospital Foundation. This takes the total donations to \$15,000. Mike will be putting final costs for the Park together
