# <u>Appeal of the Denial of Wayne Sykes Request to reside at 426 North Main Street,</u> 251-1216-1444-014.

Police Chief MacNeill indicated that Mr. Sykes is requesting to reside at 426 N Main which is 1056 feet from the Malt House grounds which is within the 1200 feet set as a safety zone by the City Ordinances. Members of the Council questioned Mr. Sykes. Ald. Olson questioned the reasons he has a number of alias listed. Mr. Sykes indicated some are nicknames from over the years and his step-father's last name. The Mayor asked why he wants to live in Mayville. Mr. Sykes indicated that he grew up in Fond du Lac and he has friends that are here. He believes moving to Mayville will provide a fresh start for his children and fiancé. Mr. Sykes is currently employed and resides in Oconomowoc. He would like to do a rent-to-own at the Main Street address as the owner is someone he knows, but hasn't moved in yet. He would then commute back and forth to work. His fiancé is in the health care field and has more opportunities for employment here. It was questioned why his status shows "non-compliant" with the sex offender registry. He explained that a couple years ago he went out of state and forgot to mail in a letter. His last contact w/ DOC was approximately 2 years ago. He has not moved or changed jobs in the last 2 years, but is aware that he is to make changes with the DOC. He was unaware that he still was in noncompliant status. It was noted that if a Sex Offender wanted to move into an area that wasn't in a restricted area the Council wouldn't need to take action. Mr. Sykes hasn't checked any other areas of Mayville that are not within the restricted zones. Mr. Sykes stated that he was last incarcerated 2 years ago due to the incident from him traveling out of state and failing to register. Other than that violation of probation, the last time he committed a crime was the offense for which he is now a registered sex offender in 2001 or 2002. He has not had any negative police contact in Oconomowoc. The relationship with his fiancé's mother was questioned. He said that he has had a few conversations with her regarding religious issues and they are working on the relationship. His fiancé's mother sees things different than she did then. The Police Chief hasn't made contact with DOC, but noted that the registry says the registrant responded to recent USPS mail is indicated "no" from January 12, 2016. Mr. Sykes will need to contact them to regain compliance. When asked if there was anything else he wanted to add he said that he would truly appreciate a chance to start over with his family and be a productive citizen that will not cause any problems.

#### **Decision on Appeal of Wayne Sykes.**
