Ald. Olson suggests instead of doing a large jump of 4%, we do a 2% every year to make it easier on the citizens. Ald. Smith would like Director Nathan Kempke present his case. Nathan went over the rate study finds; suggesting a 12% increase. The Commission recommended to Council an 8% increase. Nathan also went over future expenses that Wastewater is expected to have which is part of the need of the increase. Lois explained that wastewater has been operating in the negative, while water utility is not. Ald. Smith thinks that Wastewater Utility can be more efficient to cut costs and have a savings rather than increase rates. The Mayor thinks that new business will look at our rates and if we are high, they will go to a different municipality. Ald Toellner thinks that infrastructures should be maintained and that is why business will come to Mayville.
