The sales tax is almost entirely generated in the cities and villages in Dodge County and they see very little coming back to them. This resolution is to get the support of all the councils in the cities in Dodge County.

Attorney Hammes was not present at the meeting. He did address most of the issues regarding the Ordinance in a letter. He stated that the City of Mayville has the authority to require a property owner to repair or replace a defective sanitary sewer lateral and the City of Mayville does not have the ability to disconnect water service to a property governed by the Public Service commission rules. He recommended either discuss tonight and if there are specific issues that need further clarification, or if the council would like to discuss issues with him, table the matter until the next meeting or, simply table completely until the next Common Council meeting in which he will be in attendance.
