### 4.) Approve the Minutes of the February 22, 2017, meeting.

Motion by Gable, second by Neumeyer to approve minutes of the February 22, 2017 meeting. Motion carried 7-0.

# 5.) Discuss/Recommend Certified Survey Map for Parcel #251-1216-2343-035, 407 Seitz Avenue.

The property owner had requested to be added to this agenda for the meeting, expecting to have a CSM for review. ## a. Susan Tighe Request for Rezoning Parcel #251-1216-2313-098 and #251-1216-2313-097.

He added that the future property owner has requested an earlier date for the next Planning meeting (something prior to the scheduled 4/26 meeting date) to discuss/recommend the rezone.
