- C. Update on Banquets/Golf Outings/Events. Busy since middle of July. One to two events every weekend -golf outings, banquets (weddings, class reunions, etc.)
- D. Discuss/Approve #4 Ravine/Drainage Project. Work on Hole #4 was discussed. Bob received two quotes for the work. Bennett's Landscaping - \$18,000, Toellner's Landscaping - \$9,388. The work would include 12" to 20" boulders, slopping ditch to 45 degree angle, fabric to keep out vegetation. Tony Persha received a quote from Town and Country Construction for finishing of the ravine with same stone as around the pond on Hole #4 with no slopping of sides. Bob has received a promise of a donation from three members to be used for the work and money made on Calcutta will also be used for the project.
