A. Joe Cheeseboro updated board on audit process, some discussion about older merchandise in pro shop to liquidate it versus hanging onto it, Bob and auditor would take care of this. Item #6 Golf Course Manager Report.

- **A.** Showed the hall for weddings seven times in February and booked four of the seven of those showings. Also booked six other events for 2014 season.
- **B.** Because of the extreme frost and cold conditions, the grease trap froze up and had to be serviced in February. They had to pump the tank, hydro-jet the pipe, and auger the line to open it up for water to flow. Total bills for this added up to \$1200. This is an unexpected expense and a unique situation with the cold winter this year. We do service the tanks twice a year, and had the line augured in spring of 2013 as well.
- **C.** The Toro Rough Mower was delivered on Feb. 26, and bill has been submitted to the City for payment with grant money received.
- **D.** National report showed statistics nationwide on golf courses and current trends. Weather and economy were two biggest variables for decline in golf rounds in the past five year span.
- E. They are in the process of hiring staff for the 2014 season.
- **F.** Monday league meeting is scheduled for April 7 at 6:00pm. Thursday Men's League meetings are April 3rd at 1:30 and 6:00pm for the two separate leagues.
- **G.** The menu for Easter Brunch was shared and will be served from 10:00am 2:00pm on April 20th in the banquet facilities at the Golf Club. Reservations are recommended; walk-ins are welcome and is OPEN TO THE PUBLIC!
