- **B.** Update on Golf Course Equipment Maintenance and Repairs. Minor repairs on rough mower. Nothing serious. Have created maintenance forms for each piece of equipment, including golf carts, which will be kept in binders and all maintenance will be recorded. The new hydraulic lift is amazing.
