Don Stommel Service Appreciation Award.

Don Stommel was recognized by Mayor Bob Redeker along with the Mayville Common Council for his work over the years (from 1969-2015) with the City's Fire Department, EMS, TAG Center, and the EMS & Police & Fire Commissions.

Presentation by Robin Alvigi from Unison Cell Tower Company.

Unison is a wireless investment and development company. Unison buys, markets and manages cellular sites. It's a two phase program. The first phase is to put the municipality in a more secure position in the lease offers by offering capital (a lump sum of money up front). The second phase is to potentially add new revenue to the site by adding new tenants to the tower which Unison would share this ground rent with the city at a 50/50 basis. Unison pays the site owner a cash lump sum based on the existing lease for a wireless easement on the property. The easement is for a specific purpose – the operation of the cell site. Unison does not buy the property, only a wireless communications interest in the property, which enables Unison to pay the maximum value. Unison assumes the risk of rent reduction and lease termination.

Mayor-Monthly Report.

My wife's grandmother passed away this past week. Her life was full of happiness and challenges like most of ours. One cannot argue the fact that their generation was one of sacrifice and courage. When they were young they suffered through the depression. When they came of age they went off to fight a world war, and then some fought another one in Korea. Then after the war they came back to build the biggest and best economy the world had ever seen. They helped create and witnessed staggering advances in technology and standards of living. They also had a lot of babies. They raised them to be the next great generation; a generation that they hoped would have it better than they did. They looked at it as their responsibility. I believe they accomplished that responsibility. The baby boom generation benefited by their sacrifices to be sure. I know because I'm part of it. I cannot believe how good my life has been. It's not because my parents were wealthy but I benefited from all the sacrifices that they and everyone else made before me. I grew up in a safe and secure country. I grew up in a country that valued work, freedom and responsibility. The question is now what kind of country and for our city, are we going to leave the next generation? I bring this up because we often forget what we do today has an effect and sometimes a long effect, on future generations. One example of this would be debt. I would bring up the national debt and how out of control it is, but we all

know about that. That debt will truly take generations to fix and is an example how Washington and its leaders are failing us all. On the local level we are also not immune from the problem of debt. We are making some strides but it continues to weigh down on what we are able to do. Without the golf course or TIF debt which is paid outside the general fund. We are currently almost 4.7 million in debt (that's including interest). Our next two years we will make payments of 1.057 million and 1.052 million respectfully. Now we comfort ourselves and rationalize it by saying that interest rates are low now. We do this because borrowing money is so much easier than making tough choices. I believe we all need to understand what type of burden we put ourselves and the next generations in. Maybe it's time for our generation to show the next generation what a responsible public policy looks like. Maybe it's time to live within our means and borrow what is only necessary and essential. Paying interest on debt instead of using those resources towards investing in our city and its citizens is wasteful. We will always have some debt to be sure but it must be reasonable and necessary. We owe it to the next generation not to give them a bill that will limit their potential and freedom.
