**Item #2 – Approve the minutes of the August 22, 2016 meeting.**

**Item #4 - EMS Report.**

City Clerk read monthly report submitted by Christine Churchill. See Attached Report.

**Item #5 - Monthly Fire Department Report.**

- A. **Monthly Report.** Chief Marx reported that there have been 52 fire calls-YTD. They had the largest response ever for the flood with 29 agencies reporting. The flood was challenging due to length of the incident and size of the scene. He thanked everyone for the response from the community and other agencies. They then responded to a house fire the following Sunday. There was fast response from Fire and Police Department. The fire extinguished itself from the plumbing.
- B. **Current Staffing.** They just hired 2 more people so they are up to 27. They also have another applicant that toured the facility. They are always accepting applications. Their average is 8-12 people responding. Approximately 200 people responded to the flood. Of those, 20-26 were from Mayville Fire Dept.
- C. **Apparatus Update.** Jon Borst reported that they finished repairs in October. One will need to be retested as it didn't pass vacuum test and had to replace valves. They will be ok on budget once the repairs are done. One other has a tilt issue that needs to be fixed in order to do repairs as they can't access the engine (#2963 -2001 vehicle). They have minor repairs on the bigger truck. They are maintaining the best they can.

**Item #6 – Monthly Police Department Report.**

- A. **Personnel Update.** Chief MacNeill & Captain Vossekuil reported. On 9/19 they hired Nick Weber. They had planned on him starting 11/1/16, but due to scheduling issues he has a start date of January 1, 2017. Chief & Captain are going to training tomorrow in Appleton regarding domestic abuse.

**Item #7 Emergency Government.**

- A. **Flooding Event Update.** Chief MacNeill echoed Chief Marx regarding the flood. They are meeting on 10/3 with other agencies involved to discuss pros/cons of the response and discuss strategy for response in the future. The flood event lasted 14 hours which doesn't include DPW and Fire Department. Chief MacNeill thanked all that helped.  
Ald. Schmidt also made a statement thanking everyone involved. The quick action saved a lot of potential damage.

**Item #8 Discuss/Approve Homecoming Bon Fire on the Mayville High School grounds, Thursday, September 29, 2016.**
