Fully Staffed with 31 employees - 4 registered nurses, 3 paramedics, 11 EMT-IV tech, 8 EMT-B, 4 drivers and 1 student. 532 calls for service, billed charges \$423,849.79, gross revenue \$255,236.35, Life Quest \$40,901.09, service revenue \$214,335.24, 2014 aging (uncollected revenue) \$78,069. Earned \$7,963.61 in fundraising and received \$79,823 from the Bachhuber Foundation which was used to purchase 3 Lifepak 15 units Defibrillator/EKG. Converted an office into a fitness center for on-call EMS personnel (all equipment was donated). Moved training equipment room and converted the room to a bedroom being utilized by out of town staff members (furniture was purchased with fundraising money).
