We want to know what is and isn't acceptable. It was previously stated that the business has to leave 5 feet of sidewalk space. He feels that we need an ordinance with guidelines pertaining to this. ## <u>Item #17 - Discussion on Concealed Carry in Public Buildings.</u>

Rob Boelk feels we need clarification from our attorney and insurance carrier regarding this issue. What if someone would come in and injure someone with a firearm what is our liability? Mayville passed an ordinance preventing concealed carry in all city owned businesses. It is a misdeamer for anyone to enter a building that is owned by local government and posted it as no Concealed Carry or no Firearms Permitted, but as far as the liability goes that would be something for the insurance company to determine.
