A. Year - to - Date Statistics.

Police Chief, Chris MacNeill, reported year-to-date percentages as compared to last year at this time. EMS calls are up 58%; burglaries are down 63%; domestics are down 51%; harassment complaints are down 37%; theft complaints are up 12%; worthless checks are down 27%; 911 hang ups are up 122%, mainly attributed to pocket dialing of cell phones; suspicious person or activities complaints are up 128%; driving complaints are up 277%; and traffic accidents are down 21%.
