<u>Item #4 – Monthly Fire Department Report.</u>

A. Council Members Required Complete IS100, IS200, IS700 Courses for Grant.

Roger Williams distributed a memo to the Council explaining that the Alderpersons and the Mayor need to complete the classes so that grant monies will be available.

B. Update on Replacement of Fire Department Squad with Purchase of 2006 GMC Truck for Fire Department.

Roger reported that the 2006 GMC Diesel truck was purchased for Fire Department and it will replace the old fire squad. He noted that the truck does have 60,000 miles. The old fire squad has over 100,000 miles and is a 93 or 94 model. The squad will be sold and the monies will be used for lighting on the truck.

A. Pediatric Jump Kits.

Lori Tapola noted that a grant was applied for to pay for the pediatric jump kits. It was a \$1200 grant specific for the pediatric kits. The grant is with the Kiwanis Club. Lori described the kits as having breathing kits and measuring devices that are specific for pediatrics. There is a kit for each ambulance.

B. Pediatric Education for Pre-Hospital Professionals Course Certification.

Lori noted that there was a two day course that the EMTs took to become certified.
