### Item #2 - Approve the minutes of the January 17, 2011, meeting.

### Item #4 – Monthly Fire Department Report.

#### A. Incidents To Date for 2011.

Bill Stanke distributed a report showing the incidents for the Fire Department to date. He noted that there have been six runs, including one porch fire and two carbon monoxide detectors. He commented that carbon monoxide detectors can get old and need replaced. He also noted that sometimes the detectors need aired out.

#### A. Changing Over Sirens to Narrowband in 2013.

#### A. Police Department 2010 Activity Report.
