<u>Item #6 – Monthly Police Department Report.</u>

A. Citizen Police Patrol Program.

Chief of Police, Bill Linzenmeyer, came to the podium. He noted that he is putting together a Citizen Police Patrol Program. Volunteers would work with the police on patrol functions. The program is strictly volunteer and similar to the Dodge County Posse.

B. Firearm Program.

Chief of Police, Bill Linzenmeyer, introduced Officer Ryan Borchardt to the podium. Officer Ryan Borchardt is the Range Officer and has been for the past six years at the City of Mayville Police Department. He was also the Range Officer for one year prior to the six years for a previous employer. He gave a short demonstration of the glock weapons. Ryan also discussed the qualifications needed by the officers at the shooting range. They need one day and one night of a qualifying score with an on duty weapon, back up weapon, rifle, and shotgun. Also the bean bag shot gun and tasers are also reviewed. Scores need to be at 90% or better; none of the police officers have scores less than 95% or 96%. The Police Department will be transitioning to the glocks with lights. They are the last in the county to do so. Bill Linzenmeyer noted that it is all about the officer safety. Bill also mentioned that he may bring the old guns to the Finance Committee.

C. K9 Program.

Bill Linzenmeyer noted K9 Frankie has terminal cancer. He is working when he feels up to it. There will be a memorial service when the time comes.

D. Department Statistics/Investigations.

Bill Linzenmeyer discussed the locking of vehicles. He also noted not to leave valuables in vehicles. Bill distributed a map of thefts in Mayville.
