- III. CONSENT AGENDA/DISCUSSION/APPROVAL Motion by Toellner, seconded by Pasbrig, to approve the following Consent Agenda.

#### VII. WASTEWATER REPORTS

- A. WWTP & Liftstations Report/Discussion
  - 1. Pump #2 at East Dayton St Liftstation has been replaced and the original pump has been sent in for routine maintenance.
  - 2. Pump #1 at Golf View Liftstation has had seal failure alarm the pump is scheduled to be pulled and replaced tomorrow.
- B. Kekoskee-Leroy/Discussion
  - 1. Ron reported that Kekoskee/Leroy is not expected to connect until 2016. Ron also presented the Commission with an email that he received July 7th in regards to the state budget. The email stated that communities must give service to neighboring communities if requested and there is capacity for them. This item refers to both water and wastewater.
- C. Phosphorus/Discussion
  - 1. Phosphorus Report MSA Presentation Review/Possible Action
    - a. Tom Fitzwilliams (MSA) presented the phosphorus report and fielded questions. Motion by Toellner, seconded by Detuncq, to approve the report. Motion carried unanimously. Fitzwilliams and Boelk leave.

    - 1. Ron has instructed Kunkel to include Center St, Grand Blvd to Henninger St, with the project.
