A. Henninger St/S High St-Engineering There was nothing to report.

V. WATER PROJECTS

- A. Wells
 - 1. The iron filter backwash tanks at wells 2 & 4 cleaning complete.
- B. Towers

Discussed Verizon request to install antennas on the standpipe.

- C. System
 - 1. Valve exercising is complete.
 - 2. Scada System PLC failures caused communication loss to all wells and towers July 14th at 4:00 p.m. and July 22nd at 4:30 p.m. LW Allen was called in to make repairs both times the system was run in manual until repairs were made. A programming omission was thought to have caused

the problem. The program was rewritten and the PLC has worked normally since.

D. Private Well Operating Permit

After review of the 5-year well operating permit application for 936 Metalcraft Dr, motion by Hintz, seconded by Frechette, to approve the well operating permit for 936 Metalcraft Dr. Motion carried unanimously.

VI. WASTEWATER PROJECTS

A. WWTP

- 1. Discussed PLC failures and the affect on the WWTP and liftstations.
- 2. Heavy rains and power outages caused Ron to be called out July 15th at 12:30 a.m. until 8:30 a.m. and July 22nd at 4:30 p.m. until 9:10 p.m. No bypassing occurred although on the 22nd high flows caused sewerage to backup 3 feet onto the bar screen room floor.

B. Sanitary Sewer Collection System

Sewer Jetting is about ½ complete. The sewer on south Main St was nearly clogged with cheese from Old Fashioned Foods. Ron will write Old Fashioned Foods a letter in regards to the discharges.

C. Liftstations

Golfview Liftstation
Golfview liftstation now operating normally.

2. 4th Liftstation

The liftstation has been having periodic high level alarms that clear after about 10 minutes. Ron has raised the high level alarm float and lowered the start levels of both the lead and lag pumps. We will operate the liftstation as now programmed to see if this eliminates the alarms. There is room for further adjustment if need be.

VII. CAPITAL IMPROVEMENT BUDGET

After review of the 5-year capital improvement plan and proposed purchases for 2011, motion by Del Ponte, seconded by Hintz, to approve the budget as presented. The budget is on file.

VIII. PERSONNEL

A. Non-Union Personnel Manual
