- 1. A service break at 330 Brookside Dr. has been repaired. The break was the responsibility of the property owner.
- 2. The private well at 225 S Main St has been privately abandoned, inspected and the service to the building has been restored.

# VI. WASTEWATER PROJECTS

A. WWTP

There have been 3 call outs this past month due to freezing of the west clarifier.

- B. Collection System
  - 1. Grand Blvd sewer backup caused damage to a home's lower level. Ron authorized the homeowner to have Service Master clean the mess and send the Utility the bill to be paid and to submit a claim to City Hall for damages. Ron requested that the Commission allow him to have the section of sewer repaired this spring as this is a reoccurring problem, due to settling in the line where a new water service was installed in the 90's. The Commission approved the main repair.
  - 2. Riverview Heights sewer backup, caused by roots, was taken care of with damge to properties.
- C. Liftstations

There was nothing to report.

VII. KEKOSKEE ST – BRIDGE, CTH Y, DODGE COUNTY, DISCUSSION Discussed the replacement of the Kekoskee St bridge and what it would mean to future development and the Utilities.

## VIII. CAPITAL IMPROVEMENTS
