REPORT OF OFFICERS:

Mayor-Monthly Report.

Presentation of the 2011 Audit.

Jon Rader and Karla Gogen of Baker and Tilley presented the 2011 Audit. Jon pointed out the independent audit report or audit opinion. The Financial Statements and Internal Controls were thoroughly reviewed. Jon reported that there has been a big turn-around in the General Fund. The General Fund had \$174,000 balance at the end of the year, which was notable as in the past it has been a negative number. It was noted that debt ratio is at 31%. The TAG Center reports were discussed. It was noted that TAG Center fund owes other funds about 1.2 Million from the past, and that this will need to be addressed in the future. It was noted that at some point to divert the nine year plan amount from the General Fund to the other funds to cover the deficits. Jon noted the Landfill fund also has a negative amount. It was noted that there is discussion from the PFC that the PILOT amount from the Utility may change. Jon reported the audit went really well and Kathie Wild does an excellent job preparing for the audit. Jon reported that there were fewer than ten entries. Ald. Sertich noted the Golf Course contract issue of contractor versus agent will need to be addressed. Mayor Moede commented that Kathie Wild and the Finance Committee are doing an excellent job.

TAG Center Liason.

Mayor Moede announced that Ald. Pasbrig will be the TAG Center Liason.

The Importance of the Library and Its Resources to the Community.

Ald. Schmidt read a prepared statement in regards to the Mayville Public Library and the Resources available. He reported that the Mayville Public Library was established in 1904 with approximately 400 books. There are now 6,385 registered patrons, 4,400 are residential, and 1,985 are non-residential. In 2011 the total circulation was at 70,997. The library is open to the public and is for all ages. He mentioned that the library now offers Ebooks. They also house microfiche of the Mayville News/Dodge County Pionier from 1904 to present.
