The Public Hearing for the 2011 Budget was called to order at 6:00 p.m. by Mayor Moede. Mayor Moede explained the process for the Public Hearing. The gallery was full.

Public Hearing:

Tom Schuessler of 1315 Carolyn Blvd spoke in support of the TAG Center. He noted that the TAG Center has brought tremendous value to the community. He noted that the staff is very lean. The exercise classes keep people active.

Stanley Wolter of 60 Barwig Ave noted he came to City Hall today and looked at the longevity. He noted that the longevity should be taken out and the wages do not look bad. He spoke in favor of the outdoor pool.

Mary Ann Kenitz noted that she has lived here since 1965. She noted that she needs aquatic therapy that she cannot get from the TAG Center. She continued to speak in favor of the outdoor pool noting that her family has had good memories there. She questioned why there cannot be a boot out for the pool.

Dan Schmit of 610 Green Bay Drive questioned the article in the paper and the fountain and road.

Tom Lust of 200 North High Street noted that the TAG Center is a fine facility but there is no marketing. There should be marketing at Audubon Days and Maxwell Street Days. He noted that there should be wage cuts and to shrink management and staff and combine with other municipalities. He spoke in favor of the outdoor pool.

Angie Hintz came forward in favor of the outdoor pool. She noted that she no longer lives in the City of Mayville. She questioned what would happen to property values.

Kelli Mohr of Emmer Street came forward in favor of the outdoor pool. She questioned if the City is listening to the citizens. She noted that kids need to be outside.

Norb Dornfeldt of 232 Lincoln Lane noted that the TAG Center is a nice facility but the outdoor pool has been in town for approximately 70 years. He spoke in favor of the outdoor pool.

Gregory Justman of 19 Turner Street commented that the Council needs to open their ears and listen to the people.

Sherry Scott of 131 North Street noted that the pool was attractive when she first moved to town. She spoke in favor of the outdoor pool.

Wendy Metke of 1171 Breckenridge Street Apt 5 thanked everyone for coming in support of the outdoor pool. She asked how many people were there in favor of the outdoor pool and most of the gallery raised their hands. Wendy noted that the budget is not set in stone and the pool can be put back in the budget. She noted to take longevity out tonight. She noted that she will personally volunteer and will hold fundraiser donation drives for the pool.

Sara Giese of 313 Grove Street noted she disapproved of taking the outdoor pool out of the budget. She noted that there are a select group of people that go to the TAG Center. She noted to market the outdoor pool and to make it a beautiful place.

Gary Neuman of 596 River Drive moved to the City of Mayville three years ago. He noted that the TAG Center is a good facility for everyone. He is against the outdoor pool. It is too expensive and too much of a liability. He had back surgery and the TAG Center has helped him.

Dutch Arlan Machmueller noted that his parents moved here in the 1960s. He noted the water problem of the outdoor pool area.

Ralph Smith Jr of Betterway Drive questioned if the Council was listening to the voters. He noted that the TAG Center is a beautiful gift and questioned if the City can afford to keep it up.

Stan Wolter asked permission to come to the podium again. He noted that a recent paper reported that the Beaver Dam Council amended their budget.

Helen Roder of 301 S Walnut noted that she lives by the pool and bought the home 12 years ago. She noted that the tennis courts and basket ball areas are used all summer long by children and adults and that the lights cannot be taken away. She spoke in favor of the outdoor pool.

Bob Smith came to the podium. He noted that 17 years ago he moved here with his family after researching for the best City to move to. He commented on the flooding in the outdoor pool area.

Norb Dornfeldt of 232 Lincoln Lane came back to the podium. He noted that an additional road will add to the traffic mess at the school and there is already plenty of parking.

Carla Hagen noted that she has lived all her life in Mayville. She commended Wendy Metke on her efforts. She is a TAG Center member and believes the TAG Center has its good points. She noted the flooding of the outdoor pool area.

Wendy Metke came back to the podium she spoke again in favor of the outdoor pool and noted the fundraisers that were possible.

Steve Hebby of Betterway Drive questioned the fountain. He noted the Council should stop the big city thinking.

Jayne Murray of 257 N German Street commented that her father came to Mayville in 1878 and started many businesses. She spoke of the brickyard pool of years ago.

Nancy came to the podium. She is a visitor to the community and does plan to retire here. She noted that the TAG Center is attractive for moving to the City of Mayville. She noted that the aging needs to invest in the youth of the community.

Mike Mann commented that his family goes back to the 1850s with the City of Mayville. He was a TAG Center member but did not renew the membership. He spoke in favor of the outdoor pool.

Public Hearing was closed at 7:22 p.m. with unanimous roll call vote.

Citizens Comments

City Clerk, Deanna Boldrey, reported that a petition was received in the Clerk's office in regards to the outdoor pool today. She noted the petition will be reviewed according to the state statutes and there is a process to follow. Deanna noted she had talked to the City Attorney earlier today in regards to the petition and he advised for the Council to continue with the procedures as normal.

Resolution 4436-2010 (Approve the 2011 Budget and Set the 2010 Tax Mill Rate for the City of Mayville).

The City Clerk read the Resolution 4436-2010. Motion by Ald. Redeker, second by Ald. Sertich to approve Resolution 4436-2010 Approve The 2011 Budget and Set the 2010 Tax Mill Rate for the City of Mayville. Ald. Voss commented that he would like to see \$30,100 from the contingency fund and \$30,000 from the police department budget removed. Ald. Voss continued that he would like to see the wheel tax money appropriated to the swimming pool in 2011.

Motion by Ald. Voss, second by Ald. Redeker to remove the \$30,100 from the contingency fund. It was noted that the contingency fund is for both union and non-union. Discussion of the motion ensued. Ald. Pasbrig noted that the City is in the process of going through union negotiations and this needs to be budgeted. Ald. Sertich noted that there is disconnect with last year's increase of 8.5% last year and there was no one here and went all along with it. This year the nine year goal was met and 2.735% is the increase to the tax payer. We did everything right and challenged every department. She noted that alternatives were discussed for the pool. Ald. Voss noted that with the \$30,100 in the contingency fund is money for the union raise, and if they want to raise, they have to take it out of their budget. Motion failed 4-2, Ald. Redeker, Ald. Mastalish, Ald. Sertich, Ald. Pasbrig voted no; Ald. Voss and Ald. Gering voted yes.

Motion by Ald. Voss, second by Ald. Gering to Reduce the Police Department Wage Budget by \$30,000. Ald. Voss continued that this is due to circumstances that have recently come up. Ald. Gering questioned where it would come from. Ald. Pasbrig noted he would like to hear where it is coming from. Ald. Voss noted that the Police Chief retires in June and that there is another circumstance coming up that could be replaced at a lower rate. Ald. Pasbrig noted that two police officers were previously laid off. The \$30,000 will not come out of stationery and staples. The Police Department budget went down from last year. Ald. Gering noted that he had talked to Capt. MacNeill about the department and budgets. Ald. Sertich noted that a lot of the police department budget was challenged. Motion failed 5-1, Ald. Gering, Ald. Pasbrig, Ald. Redeker, Ald. Sertich, and Ald. Mastalish voted no; Ald. Voss voted yes.

The roll call vote was taken on the original motion after much discussion. Ald. Redeker thanked everyone for coming out this evening. Ald. Pasbrig also noted appreciation for everyone coming out this evening. Ald. Voss questioned that if in June if there is a surplus could the outdoor pool be opened. The original motion to Approve Resolution 4436-2010 Approve The 2011 Budget and Set the 2010 Tax Mill Rate for the City of Mayville carried 5-1, Ald. Voss voted no.

ADJOURNMENT.

Motion by Ald. Sertich, second by Ald. Gering to adjourn at 7:56 p.m. Motion carried 5-1, Ald. Voss voted no.
