4. New Business.

A. Fire Department:

1. Personnel Report.

No firefighters have resigned as a result of the new leadership. There are 29 firefighters now with the hope of adding new members to reach 35. Currently, there are possibly 2-3 new applicants available. Fire management to review the current Standard Operating Guide and come up with up to date changes/recommendations. Some legal issues are evident and Commission President, Michael Schmidt will discuss with our legal personnel. A special Commission meeting may be called to discuss.

2. Discussion of need for Fire Department Dispatch Position with Possible Action.

Discussion was made on if the department needs a special dispatcher. It was of the opinion of the leadership and commission that this position is no longer needed as a result of the modern communication equipment now available and used by personnel for dispatching and mutual aid requirements. Motion by Schmidt, second by Cundy to not develop the Dispatch Position. Motion carried 5-0.

B. Police Department.

1. End of Year Department Review.

Chief MacNeill reviewed with the commission statistics related to year 2012. Highlights included having responded to 4,046 calls for service (up 4.5% over 2011 - 18% over 2010). Two grants totaling \$6,585.00 were received as well as numerous training activities. A special achievement was the promotion of Ryan Vossekuil to the position of Sergeant.

2. Recognition of Sergeant Ryan Vossekuil for Ten Years of Service with the City of Mayville Police Department.

Sgt. Ryan Vossekuil was recognized by Mayor Moede for ten (10) years of service.

- 3. **Recognition of Judy Bauer for Support Person of the Year.** Administrative Assistant Judy Bauer was recognized Mayor Moede for her recent award.
- 4. Recognition of Officer Ryan Borchardt for Honorable Mention Law Enforcement Officer of the Year.

Officer Ryan Borchardt was recognized by Mayor Moede as an Officer of the Year.
