1. Call to Order and Roll Call:

2. Old Business:

Accept minutes of the March 28, 2011, meeting.

Motion by Leder, second by Kern, to accept the minutes of the March 28, 2011, meeting. Motion carried 4-0.

3. Citizens Comments:

Scott Dutzle shared with the Commission an anonymous complaint lodged against him that on recent fire call for suspected carbon monoxide he (Scott Dutzle) was sitting in the ambulance while Firefighters were working. Scott explained he was performing his duties and responsibilities as an EMT and was engaged in the training of a new EMT about what to be prepared for in this type of emergency situation. The assumption is made that the complaint comes from a fellow Firefighter, who apparently doesn't understand Scott's responsibilities as the EMT training officer. Scott indicated that this is not the first time this has happened, and he sees no other alternative but to resign his position of Firefighter.
