Item # 4 Clerk's Report.

- A. Discuss/Recommend Ordinance Addition to Section 38-3 of the Mayville Municipal Code Regarding the Common Council and Citizen Comment and Public Hearing Rules.
 - The City Clerk reported that this item is on the agenda to bring rules for the public comment and public hearings. The City Attorney has reviewed the ordinance. The Clerk reported that she had sent a request on the clerk's network asking the amount of time other communities allow for public comment; six responded five minutes; three responded with fifteen minutes; one with two minutes; and eighteen responded a three minute time limit.
