## Item # 4 Clerk's Report.

# A. Elections – 2010 Primary and Spring Elections.

The Clerk reported that there will be a Primary Election on February 16, 2010. This will be for Ward 1 and Court of Appeals Judge, District 4. The Spring Election will be on April 6, 2010. Wards up for election are Wards 1, 2, 4&7 and 6. The Mayor is also up for election. Ward one is a one year term.
