<u>**City Budget Report:**</u> After review, M. Schmidt moved to approve the March, 2018 report with; seconded by M. Henkel; motion approved.

Friends are gearing up for this year's fundraising including the Polka Dance. <u>BUILDING</u>: The building has been rekeyed and we have plans to remove the partitions in the bathroom. This will actually make the bathrooms more accessible. <u>STAFF/ UPCOMING EVENTS</u>: Ms. Kim's Amazing Animals was a big success yesterday. We have giveaways and cake to celebrate National Library Week this week as well. L. Zarnott made a motion to accept the Director's Report; seconded by G. Larson. Passed.

<u>Unfinished Business</u>: A. We discussed the status of the Library Site Committee. S. Smith motioned and L. Zarnott seconded to allow Sam Teeters to do PR work for the Library building project, voluntarily. Passed.
