Doug gave report:

Membership Report

Doug noted a couple changes were made. Last meeting it came up that some reporting errors with membership numbers were made. After 2017 with the 24/7 fobs, those members were counting twice. Monthly Financial Report

As of 4/30 we are 1/3 of the way through the year. This month was a slight amount of expenses over revenue, but we are still sitting good for the year. He received the 2nd quarter transportation aid of \$74,000. He discussed items that were over budget at this point. The interest income is way up. The fire department had some unexpected vehicle repairs. Attorney fees are at 43% of budget. Greg explained general fund 10. Ald.
