They are saving tax payers a lot of money and they are not losing any money. The mayor sees a problem that we are in direct competition with the private industry. There was discussion of the process. It was noticed that the ordinance is specific in saying that the city can do it or an RFP could be done. There was discussion if it is necessary to do an RFP. It was agreed that it is fine how it is being done now.

John gave report.

Buildings Report

The pavilion is rented every weekend with weddings. All of the shelters have been rented regularly as well. The rental income is above last year. A garbage truck hit the building at Theiler Park. They are working with Advanced to get that fixed. Some of the summer programming is coming to an end. They are slowly moving into the new parks building.

Ald. Toellner questioned the bridge. There is some new wood on it, but they are trying to finish up some lingering projects. The bridge will be painted. There was discussion with the Mayor as to if it was necessary to paint it. The bridge is safe, but they are changing out of some of the rotted boards. There was discussion on the structure of the bridge. There were parks with tree damage.

Grounds Report

They are busy with lawn care. They finished mulching around the buildings and parks. They are going to be putting new shrubs around the senior center. There was discussion on hosta plants. The dog park is complete and there is a lot of positive feedback.

Parks Projects Update Report

The fireman's field scoreboard is up and was donated. There is another one for Ziegler to install. They are working on the kayak pad and launch. They are still waiting on the kayaks until the signs are in. There are some things to finish up at Easy Street park. The Dayton Street path still has gravel down. They are waiting on the asphalt.
