Nathan gave report.

Water Distribution System Update

- · High Street water tower hit by lighting earlier this month, damage to transducer in the tower that has been replaced
- · Hydrant flushing October 14-18, 25-30 hydrants flushed during the week
- · A few fire hydrant repairs to be done yet this summer
- · Fire hydrant painting, 30 hydrants north of Bridge, between John and Furnace

The Mayor asked about the rusty water. Nathan is working on something to help clean the pipes. They will need DNR approval.

Ald. Toellner questioned the Leroy/Kekoskee agreement. He questioned if they are paying their bills. It was noted they still owe approximately \$12,000 from the city cleaning the wells from grease. There is now a pump and there have not been any further issues. Nathan is working with the City attorney. It was noted that if anyone wants to connect to the sewer it has to be approved by the Commission. If they aren't paying their bills it won't be approved.

Wastewater Treatment Plant Operations Update

- · High flows at the plant with yesterday's rain 3,000 GPM (normal is less than 1,000 GPM), plant was able to handle it and flows have come back down quite a bit but still over 1,000 GPM
- · Hydro-Klean has started their repair work on manholes around the city work will continue on and off through summer
- Will be installed new heating units on the roof of the building next month, units have been delivered to the plant and will have to be installed with a crane
- Study on leachate treatment at the WWTP has been started, should see a draft of that report this Fall
