Building Report

I am able to get work in the buildings since it is just myself and get caught up with some projects.

Grounds Report

Dan has gone through all the parks and trimmed the trees with dead branches or totally taken down the dead or diseased trees. As of today, Dan is done for a time in the parks until things settle down and parks are looking at opening.

Parks Projects

I am going to try and plant 8 to 10 new trees a year at a cost of about \$150 per tree. I am hoping to put a program together and see if we can't get a bunch of them donated.
