CITIZEN COMMENTS

Roger Zehms Mayer lane-He is against removing John Street as a truck route. He'd like the police department to give a report on safety issues. He noted he has concerns about the landfill trucks and that it could be solved by putting a road in to Highway 67 to have trucks go through the landfill rather than down John Street.

Carol Billington 870 Circle Drive-She works at Kwik Trip and sees all of the traffic on Clark Street from the canning factory and the factories. She believes there will be more accidents if you put all of the trucks there because there is not enough room. John Street has been a truck route forever and they knew that when they bought their house there. She also noted that kids walk down Clark from school. She also noted that the side streets there only have one outlet where John Street has more.

Willard Haslow 412 South Clark Street-He said the traffic isn't always bad, but when it's canning season there were 17 trucks in 1 1/2 hours. He said they don't need more traffic on South Clark Street. He is against changing the ordinance.

Lloyd Breslow 340 South Clark Street-He would like to see it left the way it is. There is enough traffic on Clark already. He believes they will have problems if they ad more traffic by Kwik Trip.

Dave Schrab 868 Alphyl Lane-He is opposed to the change. He noted John Street has been a truck route for years. They built it for heavy trucks and it should stay that way.

Judy Bauer 930 Meadow Lane-She has already given her opinion but it comes down to facts. The Police Department handles reports and traffic reports and she'd like them to note if there have been any public safety issues due to the truck route. She also noted that the intersection on 4th Street and John Street is a march sharper turn than John Street to Horicon Street.

Jason Binstock 318 South John Street-He is in favor of the change because of the population direction on John Street. There are 33 houses on John vs. 11 on Clark and there are a number with children. The cars parked on the street also cause a blind spot. Clark Street doesn't have as many blind spots. He understands Kwik Trip is a problem, but Clark Street was built with appropriate stop lights and turning radius. If he is parked by BMO he has to back up to allow a truck to turn.

Dale Gourlie 408 South Clark-He understands where John Street people are coming from. It is true that there are more houses on John Street, however you have to add the houses on horicon street and the outlet streets off Clark Street. He said there is no traffic on John during the weekend, but there is still traffic on Clark Street. He said the traffic on Clark is already to crazy.

Carla Hagan 434 Janssen Ave-She explained traffic counts that she did on her own on Horicon Street and John Street. She noted that we all need to share the burden of traffic and that all truck routes go past residential areas. She also noted that 3 of 6 alderpersons live on truck routes. She doesn't believe any changes should be made to the ordinance.

Joanne Vogel 886 Circle Drive-She has lived here 26 years. There are 58 houses in the inlet that can't get out besides Clark Street. John Street can go either way. There are also a number of EMTs and Firefighters in that area.

Joe Vogel 886 Circle Drive-There are truck routes all over town. If you start changing one others are going to want it too.

Dick Wager Mayer Lane-He agrees with Dale Gourlie. He also noted that Fourth Street is already busted up. If we allow more trucks there, we'll have to fix that too. John Street was built for a heavy truck route.

Fred Prom 931 Mayer Lane-He wrote a letter to the paper. He is against the change in the route. There has been a lot of growth in the industrial park. Moving the truck route is just passing the problem to another area.

Kim Olson 631 Seitz Ave-She thanked everyone from coming. She wanted everyone to know that it is not just 1 person that has an issue. She said historically John Street was not a truck route and the city didn't give them a heads up when they were turning it into a truck route. They have been fighting this issue for 2 decades. She doesn't like putting the traffic on Clark Street either. She noted she has a radar gun and videos. She's invited people to sit at her house. She said the landfill is the problem and they need to work on a solution together. She has a petition of people that are sick of it.

Public Safety Committee

<u>Adopt 1115-2020 (Revisions to Ordinance 397-3 through Highways; Controlled Intersections; Heavy Truck Route)</u>

There was much discussion on the topic. There was an amendment to the ordinance last month to still allow for trucks on John Street past 4th Street. Kim would like to see John Street eliminated but doesn't want to move the problem.

Motion by Ald. Olson, second by Ald. Smith to adopt the ordinance (for discussion).

It was noted that the truck route benefits the businesses down there.

Lt. Toellner discussed the safety standpoint. He has done radar on John Street and patrolled it, but from the standpoint of complaints and traffic safety, there hasn't been a lot. He discussed the other truck routes in town. From a structural standpoint, those intersections are no different and actually probably larger. It's hard to do traffic enforcement because they see the squad cars. He has even patrolled in his personal vehicle. There is nothing from a safety standpoint that says John Street is more dangerous than Clark. He did not that Ald. Olson does call with complaints. Chief Ketchem agrees with Lt. Toellner. He has been working with Mayville Metal to take the fence down.

Ald. Olson questioned what will happen when someone is injured. She noted the landfill is the problem. It had been discussed to go across the landfill to Highway 67, but they have an issue with the railroad tracks. Ald. Toellner noted that all the business in town need that truck route. Ald. Forster noted that she has read the emails/talked to people. There are some people that don't have a problem. Ald. Olson noted that she got signatures of everyone that had an issue. Ald. Smith noted that there is a problem and agrees it should be fixed someway. It falls on the PD for enforcement and the City to negotiate a more peaceful resolution with the landfill. Ald. Frings noted that he has read emails on both sides and all points are valid. He's mostly concerned with safety, so he'd have to go along with the Police Department. Ald. Olson said she wants everyone to work together because it's an accident waiting to happen.
