- We have received some of the quotes necessary for cured in place pipe lining. We are waiting on a few more to complete projects on Riverview Heights and Muzzy St.
- Chemical pumps are being modified to accommodate significantly lower chemical flows than previous chemicals used and should save a significant amount of costly chemical.

Grounds Report

I am going to be placing signs up warning people to clean up after their dogs or dogs won't be allowed in the parks. I have received numerous complaints from people who are using Ziegler Trail. I took pictures of all the waste on the trails. Mike Kurutz had said that in the past the reason nothing was done to possibly keep the dogs out of the parks was because they had nowhere to take their dogs. We have the dog park now. I am going to place signs, garbage cans and dog bags throughout the parks and if the dog waste is still not being cleaned up then we will look at becoming stricter with dogs in the parks.

Parks Projects

The Frisbee Golf Course is going ahead as planned. The construction has been pushed back slightly due to some funding coming to the Rotary from the national Rotary. The construction date is hopefully going to be in May. I am waiting for the final bid from Northwest Cable to trench in the electric for the lights to be installed on the upper dam and staircase that stretches between the Dam and German St. The Mayville Sting applied

for a grant from the Bachhuber Foundation to redo our dugouts at Theiler Park and was given the Grant.
