Calls for Service Report

They are currently 100 calls ahead of last year. They don't expect numbers should change.

Staffing Update

The staffing numbers are good. They regularly are staffing 2-3 ambulances at a time. They have very committed people and a lot from out of town. They stay in Mayville and need to look towards the future.

Training Update

They had in person training with the medical director to review meds, airways and critical skills. This month they are doing trauma training online through SSM. In August they will do another hands on training.

MONTHLY FIRE DEPARTMENT REPORT

Brad gave report.

Equipment Update

They had the hose testing done in the last couple of weeks. A few pieces failed and they will be replaced in the budget. They had their yearly ladder test and 3 ladders failed. They also tested

nozzles and one failed that was 60-70 years old. They will have yearly truck pms at the end of July/beginning of August.

Staffing Update

They are still going strong. They have 24 and are waiting for 1 to finish up paperwork. There are no current applicants at this time.

Fire Call Update

They are at 50 calls ytd. They slowed down a bit, but the severity of the calls have increased.

Ald. Frings questioned the mutual aid. It was noted that the majority are our calls. We benefit more from the mutual aid.

MONTHLY POLICE DEPARTMENT REPORT

Chief Ketchem gave report.

Equipment

They were notified on Friday that the 2 squads came in. They will be delivering them tomorrow and they will begin working on getting them outfitted. Several depts are looking for the old vehicles, so the Mayor will work with them.

Training

The officers have completed their 24 hours of training. They did fire arms and vehicle pursuit training. They have been submitted for recertification. The 2 new hires are continuing training.

National Night Out

The city is signed up for National Night Out which is the 1st Tuesday in August. It will be in Foster Park.

Discuss with Possible Action Ordinance 397-13 Snowmobiles and All-Terrain Vehicles

Ald. Abbott put this on the agenda. He questioned why this hasn't gone through in the past. The police chief explained that the police department is against it for safety reasons. There are 2 state highways that go through town and a lot of truck traffic. The ATVs/UTVs are not designed for city streets. Juneau began allowing them, but they are frequenting restaurants and taverns. He doesn't believe it will increase our downtown business activity. Ald. Riese noted that people should be accountable for themselves. Chief Ketchem said that people are welcome to trailer their equipment and then use the trails. They discussed the snowmobile access in town. They have access to the hotel and gas stations. Ald. Frings noted he was in agreement with the Chief. Waupun also is allowing golf carts, but they have to operate like a car. The Chief noted that the county requires people to be 16 years old with a valid drivers license. He said it comes down to public safety and the reward doesn't out way the risk. Ald. Smith noted the exception for maintenance use. Chief Ketchem also noted the noise issues. They would like to look into the

County's ordinance and get some more feedback. Sara explained the cost of changing an ordinance.
