# Discuss with Possible Action Industrial Park Phase #2 and Possible Funding Opportunities

Mayor and Sara met with EDA to move to phase #2 for the industrial park. Funding is available with grants for 50%-80%. It is a very involved process. Need to have an RFP to do the grant and a RFP for the project. They are looking for places where the city owns the land and have already interested companies. The Council needs to decide if we want to pursue it further or not. This is separate from ARPA money. You have to sell the land for market value. The alternative would be to run it through the TIF. We want to make sure that we are fairly certain you will get it as it'll be an expensive process to apply. The interest in the industrial park was slow at first, but there has been more interest lately. There was discussion on the previous TIF. At this point recommending to continue the discussion. The land is currently being farmed.
