Julie & Christine gave report.

Calls for Service Report

They are 22 calls ahead of where they were last year. They don't see the trend changing. There is an influx of influenza-A.

Staffing Update

They are actively seeking personnel. They would like licensed staff. They are grateful for businesses that allow the emts to leave during the day. There are also emts that are working full-time jobs during the day and then work all night in the ambulance. The call volumes continue to increase. RNs and MDs don't have to go through the schooling. They request that everyone puts the word out.

Training Update

They had training last week and are still doing online training. They focused on strokes. They have to do their license renewals in 2023.

Annual Report

Christine went through the annual report. She noted that the EMS budget is complicated because of medicare/medicaid. Their expenses also increase as their revenues increase. They discussed the billing company and they are doing well. There was a question about gross payments and gross adjustments. This could be because of aging. They are still using SDC for collections as needed. A copy of the annual report is in the packet.

Update on Governor's Plan for EMS Services Funding

There had been some questions on the governor's plan for EMS funding. The way it was phrased made it seem like there would be a lot of money available. When the money is distributed it will not be a whole lot.

MONTHLY FIRE DEPARTMENT REPORT

Mike, Jon & Brad gave report.

Equipment Update

Jon noted that the repairs have been made. They are going to schedule PMs in June. They discussed the foam that they are holding on to. They were waiting to see if there will be grants or other money available for disposing of it.

Staffing Update

No changes since last month. They are at 20 firefighters and actively looking for people. They haven't had any new applications in about 6 months. They explained that in the next 5-6 years they have a lot retiring and younger members don't tend to stay around as long. They want to use incentive money to reward people that stick around. State law doesn't require businesses to allow people to leave work.

Fire Call Update

There have been 11 calls since the last meeting. There were 17 calls year-to-date which is a few ahead of last year. They detailed the call types.
