Motion by Lodahl, seconded by Abbott to allow fence 6' high in street yard. Fence will not cause any site vision issues with the intersection.

 Request from Anthony & Nichole Debaker 901 Meadow Ln Mayville WI. 53050, Parcel #251-1216-2331-031, to place an accessory structure over 144 sf in the rear yard and eliminate the driveway. Reference Section 430-25 Accessory uses and detached accessory structures/garages of the City of Mayville Ordinances.

Motion by Lodahl, seconded by Abbott to allow Accessory structure over 144 sf to not have a driveway. Have previously allowed other residents the same variance.
