Discuss/Approve 2023 Ambulance Purchase

Christine and Julie are asking for approval to make the 2023 ambulance purchase. They don't usually purchase it this early, but it is hard to get a chassis, so they need to get on a list. The oldest ambulance they have needs \$10,000 in repairs to pass the DOT inspection. There is \$200,000 budgeted in capital improvements along with \$84,000 in their savings account and \$35,000 that comes in with the contracts.
