## General Information About Your Property Tax



### When are my taxes due?

Your entire real estate tax bill, or your first installment, is **due by January 31, 2026**. If you choose to pay in installments, your first installment is due by January 31, 2026 and your second installment is due by July 31, 2026. Make sure to pay the correct amount of your installment. Any delay in paying your taxes may cause you to incur additional charges. If paid in 2025, it will be noted on the receipt.

### Where do I pay my taxes?

### How can I pay?

Pay taxes by **January 31st, 2026**.

**Pay By Mail**—Make your check payable to the City of Mayville, write your tax parcel number on the check and enclose the payment stub (the bottom portion of your Real Property Tax Bill) and mail it to:

Remember: Escrow checks need to be signed, if your name is also on the check!

**Pay by Credit Card**—The City offers residents the option to use credit card. Please remember there is a three (3) % convenience fee.

**Pay In Person**—Taxes can be paid at the City Hall, 15 S School St:

**Monday-Friday, 8 AM-4:30PM**

**City Hall will be closed December 24, 25, 31 and January 1.**

Payments may also be placed in the drop box at the City Hall, please **DO NOT PLACE CASH** in the drop box.

### What if I can't pay my entire 1st installment amount?

All taxes are due by the deadline or may incur interest and penalties.

### When am I eligible for a Lottery Credit?

If your current residence is your primary residence as of January 1, 2025 it qualifies for the lottery credit. Please check your tax bill to verify you received the lottery credit. You can apply for the lottery credit at City Hall before paying your taxes. The lottery credit can only be taken on your primary residence.

## Grass Clippings

Grass clippings may remain on your lawn or be taken to the City Garage, located at 610 Horicon Street.

Lawns need to be maintained, per City of Mayville ordinance.

Do not blow clippings into the street. This practice may cause flooding issues.

## Curbside Leaf Pick Up

Leaf pick-up is done from the start of falling leaves until freezing temperatures. Residents can take leaves to the DPW City Garage compost pile year-round.

## Snow & Icy Sidewalks

Per ordinance 368-4 snow and ice removal: Property owners shall be responsible for the removal of snow and ice on all public sidewalks within 24 hours of snow ceasing.

If the City needs to remove the snow or ice from the sidewalk, it will be billed to the property owner.

## Chloride Reduction

Freshwater organisms cannot tolerate high levels of chlorides (salt). Water softening systems, industrial sources, and winter ice control contribute to high concentrations entering treatment facilities.

It only costs 20 cents to add a pound of salt to water, but five dollars to remove it.

A small, yet helpful step to reduce salt in the water is to change your water softener settings to reduce salt usage by 27%. Service professionals can help you with changing your settings.

## Interested in running for office in Mayville?

The position of alderperson in Wards 2, 4, and 6, as well as the position of mayor, will be up for election at the April 7, 2026 Spring Election. A Ward Map can be found on the City website. Candidacy papers can be circulated starting December 1, 2025 and are due to the City Clerk by 5PM on January 6, 2026. A "City of Mayville Candidate's Guide for Elections" is available on the City of Mayville website or can be picked up at City Hall to assist you with gaining ballot access. You can always contact the Clerk Gonstead with any questions.

If you have moved since the last election, even if it's within the City, you will need to register at your new residence. While you are there, check out the other features available to voters!

# General Information

## How can I get a tax receipt?

Enclose a self-addressed, stamped envelope along with your payment stub and payment. You can also request one in person at City Hall.

## How can I get an extra copy of my tax bill?

Copies can be obtained, for free, on the Dodge County Land Information Search Tool website. A reprint of your tax bill can be obtained from Mayville City Hall at a cost of \$0.25 per page.

## Where is my tax refund?

Refund checks will be issued to whomever paid the tax bill after the check has cleared all banks. Cash refunds are not given.

## Who can I talk to about my assessed value?

## Is a dog license required?

Yes, by state law all dogs, 5 months or older, residing in the City of Mayville are required to have a dog license. Licenses are good for the calendar year, January 1-December 31.

## What do I need to get a dog or cat license?

You need to provide a copy of your pet's current Certificate of Rabies Vaccination, a self-addressed stamped envelope, complete the below application, and your payment.

## Winter Parking Enforcement

Ordinance 1151-2025 updated winter parking. Annually, from Dec. 1 – April 1, no vehicle may be parked on any public street between 1AM and 6AM without a displayed winter parking permit, at a fee of \$50.00.

During a snow event, no vehicle may be parked on the streets from 1AM-6AM. During a snow emergency, no vehicles may be parked on public streets or alleys from the start of the snow emergency until the streets are cleared.

## Where can I purchase an off-street parking permit?

Parking permits are available for municipal lots and can be purchased at City Hall.

1-Month Permit	\$15.00
4-Month Permit	\$40.00
Annual Permit	\$110.00
